TO DISTRIBUTE ALL POULTS PURCHASED BY ME PRIOR TO 21 DAYS OF AGE, AND NOT TO SELL IN EXCESS OF 50 TURKEY POULTS PER PREMISE IN EACH CALENDAR YEAR TO ANYONE WHO IS NOT THE HOLDER OF REGISTERED ONTARIO TURKEY QUOTA OR A CURRENT TURKEY POULT DEALERS LICENCE WITH THE TURKEY FARMERS OF ONTARIO.

I WILL FULLY COMPLY WITH SECTIONS 10 AND 12 OF TURKEY FARMERS OF ONTARIO GENERAL REGULATIONS - 2019. THE COMMODITY BOARD MAY IMPOSE TERMS AND CONDITIONS UPON A LICENCE. WE AGREE TO IMMEDIATELY NOTIFY THE COMMODITY BOARD IF THERE ARE CHANGES IN INFORMATION ON THE APPLICATION FORM.
