I WILL REPORT THE CIVIC ADDRESS, TOWNSHIP, COUNTY, TELEPHONE NUMBER, EMAIL AND NUMBER OF POULTS PURCHASED BY PERSONS WHO RESIDE AT NON-REGISTERED PREMISES. THE INFORMATION WILL BE SUBMITTED TO THE TURKEY FARMERS OF ONTARIO BY THE FRIDAY FOLLOWING THE WEEK OF ACTIVITY.

FURTHER, I AGREE NOT TO SELL IN EXCESS OF 50 TURKEY POULTS PER PREMISE IN EACH CALENDAR YEAR TO ANYONE WHO IS NOT THE HOLDER OF REGISTERED TURKEY FARMERS OF ONTARIO QUOTA OR A VALID TURKEY POULT DEALERS LICENCE OR HATCHERY OR HATCHERY AGENT LICENCE WITH THE TURKEY FARMERS OF ONTARIO.
